Farm Population in FADN

- Main objective of FADN data is to cover relevant farms, in order to provide the CAP with information about:
 - ▶ The annual income of the agricultural holdings;
 - ▶ Business analysis of the agricultural holdings;
- FADN threshold could be set by applying an economic size class from Annex V of Regulation (EU) No 2015/220;
- The threshold referred to in Regulation (EU) No 1198/2014 shall ensure that the field of the survey represents the largest possible share of agricultural output, agricultural area and farm labour, of holdings run with a market orientation;
- All important types of farming should be covered;
- Scope of farms in FADN could differ by MS and could change over time depending on developments in the sector.

Farm Structure Survey – Coverage (1/5)

Art. 3 of Regulation (EC) No 1166/2008

- The survey shall cover:
 - agricultural holdings where the agricultural area utilised for farming (UAA) is 1 hectare or more;
 - agricultural holdings where the UAA is less than 1 hectare, if those holdings produce a certain proportion for sale or if their production unit exceeds certain physical thresholds.

Farm Structure Survey Coverage (2/5)

- However, Member States which use a survey threshold above 1 hectare shall fix this threshold at a level that excludes only the smallest agricultural holdings which together contribute 2% or less to the total UAA excluding common land and 2% or less to the total number of farm livestock units.
- In any case, all agricultural holdings reaching one of the physical thresholds specified in Annex II for certain crops and livestock shall be covered.
- In the choice of the criterion could be taken into account: physical size of UAA combined with nr of animals, economic size, commercial farming etc.
- In the choice of the threshold: from less than 1 to 5 hectares of UAA, from 1 to many heads of livestock, etc.

Annex II - Thresholds for the farm structure surveys and the survey on agricultural production methods

Farm Structure Survey Coverage (3/5)

Art. 3 of Regulation (EU) 2018/1091 of the European Parliament and of the Council on integrated farm statistics and repealing Regulations (EC) No 1166/2008 and (EU) No 1337/2011:

- 1. The data required by this Regulation shall cover 98 % of the total UAA (excluding kitchen gardens) and 98 % of the livestock units of each Member State.
- 2. In order to meet those requirements, Member States shall provide data representative of the agricultural holdings and common land agricultural units that meet at least one of the physical thresholds listed in Annex II with regard to the size of agricultural land or the number of livestock units.

Farm Structure Survey Coverage (4/5)

- ▶ 3. By way of exception, where the frame specified under paragraph 2 represents more than 98 % of the national agricultural production, measured by the Standard Output in accordance with Commission Delegated Regulation (EU) No 1198/2014 (1), Member States may, subject to prior approval by the Commission (Eurostat), establish higher physical or corresponding economic thresholds to reduce the frame, as long as the 98 % coverage of the total UAA (excluding kitchen gardens) and 98 % of the livestock units of the Member States is reached.
- ▶ 4. Where the frame specified under paragraph 2 of this Article does not represent 98 % of the UAA and 98 % of the livestock units, Member States shall extend the frame in accordance with Article 6 by establishing lower thresholds than those referred to in paragraph 2 of this Article, or by establishing additional thresholds, or both.

Fruit trees, berries, nut trees, citrus fruit trees, other permanent crops excluding nurseries, vineyards and olive trees	0.3 ha
Vineyards	0.1 ha
Olive trees	0.3 ha
Greenhouses	100 m ²
Cultivated mushrooms	100 m ²
Livestock	1.7 LSU



Farm Structure Survey Coverage (5/5)

- ▶ Article 6 - Frame extension
- ▶ 1. Member States that extend the frame in accordance with Article 3 (4) shall provide core data on the agricultural holdings included in that frame extension for the reference year 2020, covering the information specified in [Annex III](#).
- ▶ 2. The data collection on the agricultural holdings in the frame extension may be carried out on samples. In that case, Member States shall ensure that the weighted results are statistically representative of agricultural holdings within each region and are designed to meet the precision requirements set out in [Annex V](#).

Selection Plan for FADN 2018


- ▶ Single FADN-Region for Romania;
- ▶ Threshold for participation increased from 2000 to 4000 euro;
- ▶ Number of farms participating decreased from 6000 to 5100;
- ▶ Sample frame was represented by Statistical Farm Register, updated with FSS 2016 data;
- ▶ SO 2013 was used for economic size and farm typology calculation.







FADN Sample Frame and Sampling Rate





What will be after 2020?

- FSS – 2020: the ***Regulation (EU) 2018/1091*** will be implemented for the first time
- Proposals for carrying out the survey:
 - Implementing thresholds for the big farms, which will be exhaustively surveyed
 - Small (subsistence and semi-subsistence) farms will be surveyed in a sample, only for the core variables
- SO 2017 will be used for economic size and farm typology calculation
- Statistical Farm Register, updated with FSS 2020 data will become sample frame for FADN starting in 2022
